14.00-15.30 SESSION II: PARLIAMENTARY DRIVES TO PROMOTE POTENTIAL OF BLUE ECONOMY TO ENSURE SUSTAINABLE DEVELOPMENT OF MARINE RESOURCES

Oceans play a key role in determining sustainable development and poverty eradication in Pacific Islands as well as in Indonesia. While there is no universally agreed definition, the concept of a blue economy is generally understood to be a coherent, integrated, sciencebased approach to managing the economic development of the ocean and its resources, while improving human well-being and social equity, and preserving the environment and the integrity of marine and coastal ecosystems.

Implementing a blue economy will require a move away from business-as-usual practices to embracing more inclusive, equitable and integrated approaches to the way in which marine resources and ocean ecosystems are valued, used and managed. However, implementing a blue economy highly require sustainable management and protection as set in Goal 14 (Life Under Water) of SDGs to avoid significant adverse impacts Blue Economy is also endorsed in the outcome document of the UN Oceans Conference 2017; "Our Ocean, Our Future: Call for Action" which aspire for an increase in the economic benefits to Small Island Developing States and Least Developed Countries from the sustainable use of marine resources, including through sustainable management of fisheries, Aquaculture and tourism by 2030.

Participants are encouraged to discuss the elaborative issues presented by the speakers including means and ways to promote engagement of Parliament in promoting blue economy.

15.30-17.00 SESSION III: HUMAN CAPITAL DEVELOPMENT AS A NEW DRIVING FORCE FOR ECONOMIC GROWTH IN INDONESIA – PACIFIC PARTNERSHIP

The Sustainable Development Goals (SDGs) is a product of a highly global conversation process of a new global development agenda that are more reflective on human capital development principles. Expanding human capabilities by addressing basic human deprivations continue to be the focus while at the same time maintain inclusiveness based upon the basic tenet of "leaving no one behind". Human capital is interlinked to most Goals of the SDGs, and in terms of measurement, it can be aligned to some of the 17 Goals indicators and contribute to tracking progress in areas such as education, inequality and women's empowerment.

Human capital is key driver of economic growth. Studies often find the positive correlation between human capital and growth by holding that knowledge embodied in human being is important for innovation and productivity. It has been integral to global efforts to support the SDGs promises to address the complex and multidimensional challenge of poverty, vulnerability, inequality and exclusion. This is including empowerment of women and youth, who are constitute the most vulnerable groups of society and susceptible to poverty and crisis.

Parliament as a law-making institution has a key role in shaping policies and regulatory frameworks that promotes participation, gender equity, social justice and sustainability for all. Hence, this session will discuss how Parliaments can contribute to capacity building and human capital development. 13.30-16.00 Integrated and Sustainable Eco Development of Jakarta Bay (Ancol)

Ancol is lowland coastal area located in North Jakarta. It is one of the example for integrated coastal and maritime development in Indonesia that aligning the maritime economy and environmental preservation. This area consists of eco-park, central maritime hub, and public recreation center within one large area. This spatial is environmentally designed with greeneries, coastal erosions and abrasion prevention system as part of Jakarta Bay conservation efforts.

Recognizing that waste management is one of the biggest challenge in sustainable management of coastal area, Ancol has the initiative for a self-contained waste treatment plant since 2012. The "Ancol Zero Waste" has an area of 360 m2 and is located in the eastern part of Ancol recreation area.

The Eco-park offers various object of destinations such as large varieties of tropical vegetations stretched in Ancol, Indonesian fauna, educational facilities for families about environment preservation, and eco market which promotes Indonesian Small Medium Enterprises products, which makes Ancol as one of the most popular destination in the city.

Fauna land is a zoo also located in Ancol and stands on an area of approximately 5 hectares consisting of land and water. Fauna land brings the concept of local culture which is a blend of Asian and Australian continents thus creating the beauty of the flora, fauna and cultural arts of the area.

This concept presents unique and rare animals from various regions in Indonesia, especially the eastern region of Indonesia and also the countries in the world. The land is packed in such a way that aims to make visitors feel the experience that cannot be obtained elsewhere.
