VISA REQUIREMENTS

- (I) All delegates must use a valid passport, **with an expiry date at least 6 (six) months after the date of entry into the territory of Indonesia** and ensure that the passport contains **available blank pages** for stamps on entry into and exit from the territory of Indonesia.
- (II) Delegates who are holders of a Diplomatic Passport or Official Passport of the 91 countries which have a Mutual Visa Exemption agreement with the Republic of Indonesia (listed [here](#)), are allowed entry to the Republic of Indonesia without a visa for a maximum duration of 30 days without extension, by providing these documents:
- Diplomatic Note or Organization Letter to the Embassy/Consulate of the Republic of Indonesia, requesting a visa;
 - Assembly Convocation or Invitation from the Indonesian Parliament;
 - Confirmation of registration from the IPU registration system;
 - COVID-19 Vaccination Certificate (full dose). If the delegate cannot get a full dose of vaccine due to comorbidity or other health reasons, the delegate must enclose an official health declaration form explaining the condition from authorized Health Officials, issued by a specialist doctor from a government/state hospital.
- (III) All other delegates shall contact the Indonesian Embassy / Consulate accredited to their country and close to their place of residence in order to obtain a service visa by providing these documents:
- Valid diplomatic/official /regular passport;
 - Diplomatic Note or Organization Letter to the Embassy/Consulate of the Republic of Indonesia, requesting a visa;
 - Assembly Convocation or Invitation from the Indonesian Parliament;
 - Colour photographs (dimension 3x4 cm, with white background);
 - Print out of participation confirmation automatically generated by the IPU's online registration system;
 - COVID-19 Vaccination Certificate (full dose), see Health Protocol Note for full details. If a delegate cannot get a full dose of vaccine due to comorbidity or other health reasons, the delegate must enclose an official health declaration form explaining the condition from authorized Health Officials, issued by a specialist doctor from a government/state hospital.

Please bear in mind that due to the challenges of the COVID-19 situation, the visa process can take up to three weeks, starting from when the required documents have been completed and submitted.

(IV) In the absence of an Indonesian Embassy in their country, delegates may apply online for a visa by sending the following documents to the Indonesian Parliament Secretariat at visa144@dpr.go.id :

1. Copy of passport that is valid for at least 6 (six) months;
2. Guarantee letter from the Indonesian Parliament Secretariat (provided by the host Parliament once all the other documents have been submitted);
3. Return ticket or connecting ticket to continue to another country;
4. Colour photographs (dimension 3x4 cm, with white background);
5. COVID-19 Vaccination Certificate (full dose) (*If delegate cannot get a full dose of vaccine due to comorbidity or other health reasons, the delegate must enclose an official health declaration form explaining such condition, issued by a specialist doctor from a government/state hospital*);
6. Statement of willingness to comply with health protocol in Indonesia;
7. Proof of health/travel insurance or Statement of willingness to pay independently for the cost of treating COVID-19 while in Indonesia;
8. Confirmation of registration from the IPU registration system.
