CHARLES CHAUVEL (Speaker)

Officer-in-Charge, Governance and Peacebuilding Cluster, Bureau of Policy and Programme Support, UNDP



Mr. Chauvel leads the Inclusive Political Processes team in the UNDP New York Headquarters. His team supports UNDP country programming on civic engagement, constitution-making, elections, parliaments, and women's political participation. Before UNDP, he served for 7 years as a member of the House of Representatives in the Parliament of New Zealand, representing the New Zealand Labour Party. He was at various times Parliamentary Private

Secretary to the Attorney-General, then Shadow Attorney-General, and Shadow Minister for Justice, Courts, and Corrections; Arts, Culture, and Heritage; and environment, energy, and climate matters. He chaired the Parliament's public accounts committee, scrutiny of regulations committee, and privileges committee. Mr. Chauvel was the first person of Pacific Island ancestry to have served on the front bench of any NZ political party. He founded the NZ Chapter of the Global Organisation of Parliamentarians Against Corruption, and Chaired the NZ/European Union Parliamentary Friendship Group.



Franklin De Vrieze (Speaker)

Senior Governance Adviser at the Technical Advisory Unit of the Westminster Foundation for Democracy (WFD) in London.

He offers context analysis assessment, programme quality assurance and parliamentary advice to WFD country teams in Europe and Central Asia, Middle East and North Africa (MENA), and South-East Asia. He conducts research on new and innovative themes for parliamentary

programming. Most recently, he has focused on Post-Legislative Scrutiny, and on Parliament's interaction with independent institutions and regulatory agencies. A Belgian national (1967), Franklin De Vrieze has worked on governance issues for 20 years. Before joining WFD, he has worked for the OSCE Mission in Kosovo, the United Nations Development Programme (UNDP), European Union Delegations, Swiss Development Cooperation (SDC), National Democratic Institute (NDI), Inter-Parliamentary Union (IPU) and other governance and parliamentary strengthening institutions. He has been leading parliamentary identification, formulation and evaluation missions. He has worked on parliament's role in anti-corruption, constituency offices feasibility and regional parliamentary cooperation. He is the author of several academic and policy publications.
